- 1. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered

product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25 % percentage of total quantity. The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023. OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017.

- 8. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 80% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.
- 9. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:
 - i. If number of technically qualified bidders are only 2 or 3.
 - ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.

1. Turnover

Bidder Turn Over Criteria: The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Turnover

OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria. 3. Warranty

Warranty period of the supplied products shall be as given in specifications from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

4. Forms of EMD and PBG

The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. Vendor Qualification Criteria: The broad criteria for qualifications of bidders should be in the following t erms:

Technical Capabilities and other requirements

- a) Minimum 02 year experience in Server/HPC installation. Vendor should provide authentic certificate(s).
- b) Technical details with technical parameters are to be provided along with bid.
- c) Technical documentation is to be provided along with bid.

d) Past Experience

The OEM should have a minimum of 5 installation with similar system for Deep learning & Machin e learning in different institutes (preferably in Gov. of India Labs, IITs, IISc etc.)

The Bidder should have 2 such installations along with support to customers on ML/DL.

For fulfilling the experience criteria, Purchase Order copy along with Invoice(s) and Execution certificate by client with order value should be provided.

- e) In future, if required by DTU, the OEM may agree to work together with DTU in a strategic partne rship to develop skills in AI/DL and lead national technological capabilities in the context of rapidly growing global developments in the field of Artificial Intelligence/Machine Learning/Deep Learning. In such a scenario, OEM may coordinate and help connect DTU to other Global Universities and res earch organizations who are OEM's partnered institutes and have similar systems and project with common interests.
- f) The bidder should provide free access to GPU Teaching kit on Deep Learning
- g) The bidder should plan for 'Train-the-Trainer' of DTU designated staff through Deep Learning Institute Program.
- h) The vendor will have to provide product support as mentioned in the required specifications (uploaded by the buyer along with bid on GeM).
- i) Installation & Commissioning will have to be provided by the vendor as mentioned in the require d specifications (uploaded by the buyer along with bid on GeM). Benchmark should be reproducible on premises. Report on benchmarks and power consumption stats during HPC run should be included as part of installation report.

2. Malicious Code Certificate:

The seller should upload following certificate in the bid:-

- (a) Bidder needs to arrange exhaustive training to the technical staff of DTU to ensure ease o f operation and usage. Bidder may need to repeat such trainings (maximum 1 in a quarter) in case required by DTU.
- (b) Bidder need to provide Single point of contact and also share the support and escalation matrix with details like eMail IDs and Phone nos.
- (c) Manufacturer authorization: Manufacturers Authorization Form (MAF)/ Certificate from OE M for the AI Compute Node, GPUs and Network Switch need to be submitted with details su ch as Bid No., OEM name, designation, address, email ID and Phone No. required to be fur nished along with the bid.
- (d) OEM / Bidder shall declare that, the quoted products support should would be available for the next 5 years from the date of supply.
- (e) OEM / Bidder shall declare that, the quoted products are brand new and not refurbished and re paired products.

SECTION - B Payment Terms
